## **Eureka High School Summer Driver Education Program**

### **Parent Information and return sheet:**

- 1) The Summer Driver Education Program is open to students entering Grade 9 or older unless there has been prior administrative approval. Students must be age 14 by the first day of class. (May 27, 2025)
- 2) The classroom section of the course will be offered from May 27 through June 13, 2025.
- 3) Each student will be assigned a driving slot between May 29th and June 25th. Weekends may be included. This slot will be issued at the March 5th meeting.
- 4) Transportation to and from the school to attend the summer course is the responsibility of the student.
- 5) Summer Driver Education is open to students in Eureka Public Schools.
- 6) **The first thirty-six (36) students will be accepted.**
  - A. A \$130.00 fee per student will be assessed to offset the cost of textbooks, car rental and permit fees.
  - B. Students retaking the course will be assessed the \$130.00 fee
  - C. Following in district enrollment, out of district students may be considered for enrollment after February 24<sup>th</sup> with approval from instructor and administration.
  - D. Out of district student fee will be \$230.00
  - E. Fee deadline – February 24, 2025 – To insure a slot in the session the fee must be paid or agree to the payment plan with Mrs. Lowe's approval.
- 7) **All students are encouraged and highly recommended to obtain their Instructional Permits (IP) when they turn fourteen. Prior practice, with an Instructional Permit is encouraged and will aid the student in passing this course.**
- 8) The district will follow any changes in federal and state regulations.
- 9) Enrollment Dates: January 22, 2025 – Informational Meeting during eighth hour.
  - February 24, 2025 – Fee deadline
  - February 26, 2025 - Student Permit Meeting – 10:30am
  - February 26, 2025 – Parents & Student Meeting – 5:30pm auditorium
  - May 1, 2025– Pick up text and study guides & meeting
  - May 27 ,2025 – Course begins
- 10) The student must pass each classroom test with an 80%. The student will be given three attempts to pass or will no longer be able to continue with the class.

**Refund Policy** – Refunds are as follows: If canceling by the first day of class or driving, whichever comes first, you may receive a full refund, less the amount for the permit fee and handbook. If canceling by day five you will receive half of your payment as a refund. There will be no refund given after the fifth day.
